**SLC Legislator:** -The County held a recent open house at the new highway department outpost located between Canton and Potsdam. There was a good turnout and gave the public the opportunity to view the new facility.

-SLC Drug Task Force recently presented a report to the Legislators. Through the 31<sup>st</sup> of March of this year, there have been a total of 1,041 drug incidents in the county. Of these, there are currently eighty-nine (89) open cases. There have been fifty-seven (57) felonies, thirty-three (33) misdemeanors charged, twenty-two (22) overdoses, and three (3) overdose deaths. In 2023, over one million dollars were seized, as well as 37 illegal guns.

-Emergency Services Building renovations are moving along well.

-The construction of the new bridge over the Grasse River (Lazy River Bridge) has begun, as the bridge was closed April first. An anticipated opening date for the new bridge is November first of 2024.

**Bills/Income/Expenses:** The bills for the month of March were presented by the Clerk in the amount of \$809.13 for expenses and \$569.28 income.
