The regular Richville Village Board meeting was held on Wednesday, June 7, 2023 at the Village Hall and was called to order at 5:35 PM by Mayor Ella Mae (Bluejay) Fenlong.

Tony stated that he had received an email from a resident asking some questions regarding village issues. Tony contacted NYCOM for the answers.

- 1- How many members make up a quorum for this board? More than 50% so for Richville it would be 3 of the 5 members
- 2- Should the empty seat been filled – NYCOM stated that it should have been filled by a special election or Mayor appointment if there were interested candidates. The seat should be filled at the next election.
- 3- Should a trustee hold there seat and work for the Village? - NYCOM stated that with very small villages, this is quite often and issue. If no one answers the advertisement for the bids, then continue as you are. As long as the bids were advertised you have done due diligence and continue.

Adjournment: With no further business, a motion to adjourn was made at approx. 6:06 pm by Bluejay and seconded by Eugene Prashaw. Meeting adjourned.
