There was no one from the community who attended either in person or via ZOOM.

Supervisor, John Frary opened the Town of DeKalb Organization meeting at 7:01 PM.

A motion was made by Michael Livingston and seconded by Andrew Fenton to appoint **Charles Nash** as Town Attorney, at the sum of **\$3,300.00**. Mr. Nash will take the Oath at the regular Board Meeting. Vote: Michael Livingston yes, Ed Newcombe yes, Connie Elen yes, Andrew Fenton and John Frary yes.

The sum of **\$20.00** per day for boarding and keep per dog. The sum of **\$200.00** will be paid for the Lease/service for Dog Pound/shelter Services, shall also include the cost of euthanasian and burial should it be required after any mandated time has expired and provided in Article 7 of the Agriculture & Markets Law.
